CLYDESDALE HARRIERS.

Rules.

I.—That the Club be called the "CLYDESDALE HARRIERS."

II.—That the object of the Club be the promotion of Amateur Athletics generally, and Cross-Country Running in particular.

III.—That the general management of the Club be vested in a Committee not exceeding Eighteen Members, of whom Fifteen shall be elected at the Annual General Meeting of the Club, including, at least, a President, Vice-President, Secretary, Treasurer, Captain, and Vice-Captain. One representative to be elected by each Section. Five Members to form a quorum.

IV.—That each Candidate for election, upon filling up a form (on which the Rules of the Club are printed) declaring that he is an amateur, according to the following definition:—An amateur is one who has never competed for a money prize or staked bet, or with or against a professional for any prize, or who has never taught, pursued, or assisted in the practice of athletic exercises as a means of obtaining a livelihood;—and that he will abide by the Laws of the Club, shall be proposed by one Member and seconded by another, after which his name will be submitted to the Committee, and, if agreed upon, passed. Any Member of Committee shall have the power of demanding a Ballot in the case of any Candidate. One black ball in four to exclude.

V.—That the Annual Subscription for Ordinary Members be Three Shillings and Sixpence, payable on the 1st of October in each year; and that the Subscription for Life Members be One Guinea. New Members' Subscriptions must be paid within One Month from the date of notice from the Secretary that their application has been passed, otherwise their election may be declared null and void.

VI.—That the Treasurer shall place before the Committee the names of all Members one month in Arrears for Subscriptions or other moneys, the Committee then having the power to enforce payment of such by legal proceedings, if necessary, and no one whose Subscription has been allowed to fall in arrears shall be entitled to any of the rights and privileges of Members of the Club.

VII.—That any Member intending to withdraw from the Club shall give written notice to the Secretary before the Annual General Meeting, or be liable for another year's Subscription.

VIII.—That any Member violating the Rules of the Club or of the amateur definition, as per Rule IV., or doing anything prejudicial to the interests of either, may be expelled from the Club by the votes of two-thirds of the full Committee.

IX.—That the uniform of the Club be Black Knickers and White Jersey, and that the Club Badge (a Horn and Whip, with the motto, "Excelsior,") be worn on the left breast at Athletic Sports, and the Gate Badge on back at Cross-Country Runs. (Members are specially requested to enter under the name of the Club at Athletic Meetings.)

X.—That the Committee shall allot the Management of the Headquarters' Districts to certain of its members, who will look after said Districts, and assist the Secretary and Treasurer, so far as these are concerned, the Section Committees appointing their own District Managers, and otherwise looking after the immediate business of their Sections. The Committee shall appoint any Sub-Committees which they may consider advisable, and have full power to fill up vacancies in the General Committee and act for the Club (except to alter Rules), the majority in all cases to decide, the Chairman or President of the Club, however, having the power to appeal to a full Special General Committee Meeting. That the Meetings of Committees be held on the first Thursday of each month, or as near that date as possible, at least two days' notice to be given by the Secretary when, together with other current business, the Minutes of the Sub-Committees, as well as the Treasurer's Financial Statement up to the end of the previous month will be read and considered.

XI.—That the Annual General Meeting be held early in September, and called by Circular. The Reports of the Secretary and Treasurer shall be submitted, and the Office-bearers and Committee (with

Auditor to act in conjunction with one appointed by the Committee) appointed for the ensuing year. Twenty-five members shall form a quorum; a majority to decide. The Chairman shall have the power to appeal to a Special General Meeting on any special business, at which there must be Thirty Members present.

XII.—That a Special General Meeting may be called by the Committee, or by any Ten Members, or (in the above special case) by the Chairman on giving notice to the Secretary, who shall call the meeting in the same manner as the A.G.M.

XIII.—That these Rules be annexed to the Forms of Election and inserted in the Club's "Annual," and that no alteration in, or addition to, the Rules be made except at the Annual General Meeting, or at a Special Meeting called for that purpose. Notice of such alteration to be given to the Secretary, not later than 1st September, or ten days previous to any Special General Meeting.

Cross-Country Regulations.

I.—That Cross-Country Runs be held on Saturdays, from the 1st of October to the end of March, or on such dates as the Committee may fix.

II.—That the Club when out for a run shall be under the management of the Captain or Vice-Captain, or Senior Member of Committee present, who shall appoint a Pace-Maker and Whip for the control of each pack.

III.—That no one, when out for a run, shall be allowed to go ahead of the Pace-Maker, unless the run be a racing run, or the signal be given by the Pace-Maker for a race home.

IV.—That every member of the Club is expected to wear the Club Uniform at the Club Runs, and to support the management for the time being.

NOTES

FROM THE

Fourteenth Annual Report of the Club.

THE Membership practically stands at the same figure as at this period last year, the new Members counter-balancing those who have had their names removed from the Roll.

A regrettable feature is the large number of Members in arrears with subscriptions, and although your Committee have full power to enforce payment of these, they are very reluctant to take extreme measures, and the possibility is that their names will be removed from the Roll, when it is convenient to do so, although that will not free them from their share of the Club's liabilities.

The good feeling which has always existed between our only remaining Section (since this report was submitted a new Section has been formed at Airdrie), Dumbarton-

shire, has increased rather than diminished during the past year, and so long as the present healthy rivalry between the Parent Body and the Section continues, the present harmonious intercourse is not likely to be broken.

The Season was inaugurated on 1st October at Thornliebank Baths, and concluded at Gourock on 25th March. The attendance fluctuated considerably. It is regrettable that Members cannot be relied upon to turn out to the Runs when there are counter attractions in the City. The attendance in some instances was not worthy of the Club. A decided improvement is wanted in this department during the coming Season.

As in former years, the Club held a Grand Open Handicap and Team Race. The race was run on 26th November from Corporation Baths, Maryhill, and a large and representative entry was received. The result was as follows:—Winner of Handicap, Robert Mackie, Whiteinch Harriers; first man home, Thomas Goldie, Coatbridge Harriers; 1st Team, Bellahouston Harriers; 2nd Team, Whiteinch Harriers; 3rd Team, Olympic Harriers.

A protest from Joseph Hall, who finished third, against Thomas Goldie and D. Bennie for cutting the trail was fully gone into at a special Meeting, but dismissed.

The Club Championship and Team Contest, originally fixed for Thornliebank, had to be postponed owing to fog, but it was subsequently held at Cardross. Three Teams took part, viz., President's, Secretary's, and Dumbartonshire.

The Individual Championship was won by D. W. Mill, and the Team Championship resulted in a tie for first place between the President's Team and the Section, with the Secretary's Team one point behind. On resorting to the usual mode of deciding such matters, Dumbartonshire were lucky enough to win the 1st Badges.

Our Teams did not occupy favourable positions in the Cross Country Championship, but the performances of J. Thyne in the Junior, and D. W. Mill in the Senior, were worthy of members of the Club.

The Annual Sports were held on Ibrox Park, Govan (kindly granted by the Rangers F.C.), on May 20th, and it is gratifying to be able to record, that after paying all expenses, a credit balance could be reported. We had the honour of introducing to the Glasgow public, World's Champion Hugh Welsh. A Five-a-side Football Tournament (by some regarded as a relic of bye-gone days, in so far as Glasgow is concerned) was also introduced, and judging by the enthusiasm evinced, could be counted as

one of the successes. Vale of Clyde won the first prizes.

Our Members on the path, although not so numerous as in former years, have done uncommonly well. General satisfaction must be expressed in the fact that the only Championship retained in the "West"—viz., the Broad Jump—was won by Hugh Barr, one of the Club's members.
