CLYDESDALE HARRIERS.

Rules.

I.—That the Club be called the "CLYDESDALE HARRIERS."

II.—That the object of the Club be the promotion of Amateur Athletics generally, and Cross-Country Running in particular.

III.—That the general management of the Club be vested in a Committee not exceeding Eighteen Members, of whom Fifteen shall be elected at the Annual General Meeting of the Club, including, at least, a President, Vice-President, Secretary, Treasurer, Captain, and Vice-Captain. One representative to be elected by each Section. Five Members to form a quorum.

IV.—That each Candidate for election, upon filling up a form (on which the Rules of the Club are printed) declaring that he is an amateur, according to the following definition:—"An amateur is one who has never competed for a money prize or monetary consideration, or for any declared wager or staked bet; who has never engaged in, assisted in, or taught any athletic exercise as a means of pecuniary gain; and who has never taken part in any competition with any one who is not an amateur";—and that he will abide by the Laws of the Club, shall be proposed by one Member and seconded by another, after which his name will be submitted to the Committee, and, if agreed upon, passed. Any Member of Committee shall have the power of demanding a Ballot in the case of any Candidate. One black ball in four to exclude.

V.—That the Annual Subscription for Ordinary Members be Three Shillings and Sixpence, payable on the 1st of October in each year; and that the Subscription for Life Members be One Guinea. New Members' Subscriptions must be paid within One Month from the date of notice from the Secretary that their application has been passed, otherwise their election may be declared null and void.

VI.—That the Treasurer shall place before the Committee the names of all Members one month in Arrears for Subscriptions or other moneys, the Committee then having the power to enforce payment of such by legal proceedings, if necessary, and no one whose Subscription has been allowed to fall in arrears shall be entitled to any of the rights and privileges of Members of the Club.

VII.—That any Member intending to withdraw from the Club shall give written notice to the Secretary before the Annual General Meeting, or be liable for another year's Subscription.

VIII.—That any Member violating the Rules of the Club or of the amateur definition, as per Rule IV., or doing anything prejudicial to the interests of either, may be expelled from the Club by the votes of two-thirds of the full Committee.

IX.—That the uniform of the Club be Black Knickerbockers and White Jersey, and that the Club Badge (a Horn and Whip, with the motto, "Excelsior") be worn on the left breast at Athletic Sports, and the Gate Badge on back at Cross-Country Runs. (Members are specially requested to enter under the name of the Club at Athletic Meetings.)

X.—That the Committee shall allot the Management of the Headquarters Districts to certain of its members, who will look after said Districts, and assist the Secretary and Treasurer, so far as these are concerned, the Section Committees appointing their own District Managers, and otherwise looking after the immediate business of their Sections. The Committee shall appoint any Sub-Committees which they may consider advisable, and have full power to fill up vacancies in the General Committee and act for the Club (except to alter Rules), the majority in all cases to decide, the Chairman or President of the Club, however, having the power to appeal to a full Special General Committee Meeting. That the Meetings of Committees be held on the first Thursday of each month, or as near that date as possible, at least two days' notice to be given by the Secretary when, together with other current business, the Minutes of the Sub-Committees, as well as the Treasurer's Financial Statement up to the end of the previous month will be read and considered.

XI.—That the Annual General Meeting be held early in September, and called by Circular. The Reports of the Secretary and Treasurer shall be submitted, and the Office-bearers and Committee (with

Auditor to act in conjunction with one appointed by the Committee) appointed for the ensuing year. Twenty-five members shall form a quorum; a majority to decide. The Chairman shall have the power to appeal to a Special General Meeting on any special business, at which there must be Thirty Members present.

XII.—That a Special General Meeting may be called by the Committee, or by any Ten Members, or (in the above special case) by the Chairman on giving notice to the Secretary, who shall call the meeting in the same manner as the A.G.M.

XIII.—That these Rules be annexed to the Forms of Election and inserted in the Club's "Annual," and that no alteration in, or addition to, the Rules be made except at the Annual General Meeting, or at a Special Meeting called for that purpose. Notice of such alteration to be given to the Secretary, not later than 1st September, or ten days previous to any Special General Meeting.

Cross-Country Regulations.

I.—That Cross-Country Runs be held on Saturdays, from the 1st of October to the end of March, or on such dates as the Committee may fix.

II.—That the Club when out for a run shall be under the management of the Captain or Vice-Captain, or Senior Member of Committee present, who shall appoint a Pace-Maker and Whip for the control of each pack.

III.—That no one, when out for a run, shall be allowed to go ahead of the Pace-Maker, unless the run be a racing run, or the signal be given by the Pace-Maker for a race home.

IV.—That every member of the Club is expected to wear the Club Uniform at the Club Runs, and to support the management for the time being.

NOTES

FROM THE

Fifteenth Annual Report of the Club.

IF there is one thing more than another that must appeal to all who were present in a similar capacity a year ago, it is the rapidity of time. To look ahead at any period, a twelvemonth seems in the distant future, yet, on reflection, 'tis but a day. The wheels of time wait for no one, so if we who pride in the motto, "Excelsior," wish to keep "pace" o'er "Field and Fen," it bestirs us to hasten with this, the Fifteenth Annual Report, so that when the Tally Ho resounds, the pioneers of Cross Country Sport in Scotland will help to make the welkin ring.

If you remember, gentlemen, when I submitted the previous report I took a most gloomy view of the Club's position, and at that time not without reason. We had no club honours to submit—a state of affairs you were not in the habit of being content with. We were, in fact,

passing through a crisis in the Club's history, yet, despite it all, we weathered another season, and, as this Report shows, regained a portion of our prestige. To give the Membership of the Club at this stage would be a difficult matter. We still retain on the roll all those who have not intimated their resignation, while since last year the successful initiation of the Airdrie Section has taken place, and assisted materially to strengthen our usefulness. Including its Membership, 50 new Members have been added to our roll. The financial side of the Club will be submitted by your Treasurer, and regret must be evinced we are still a little on the wrong side of the ledger. Enthusiasm and united effort would not be long in wiping our obligations off, and I am afraid, if we are to realise that happy condition, it will require to be by ourselves, as our appeals of late to outsiders have bordered on the frequent. It lies with you then, gentlemen, to be up and doing with practical suggestions to save the Club from any retrograde policy. The season opened as usual on the first Saturday of October, and extended till 31st March. Inter-Club runs were held with the Sections, Edinburgh Harriers, Paisley Harriers, Glenpark Harriers, Rosebank Athletic Club, Dennistoun Harriers, as also West of Scotland Harriers after a lapse of joint intercourse of some half-dozen years. The attendances at the runs

were, on the average, better than the previous year, although some of the distant runs were disappointing, some little complaint being made at the frequency of country visits—a state of matters I admit, and which will require to be taken into consideration in making up next season's run card.

The Five Mile Novice Handicap was won by John Cunningham, Dumbartonshire Section, he being also first man home.

The Five Mile Open Handicap was won by Joseph Brickley, who finished second in the race—our Club Champion, D. W. Mill, occupying premier position.

The Team Contest and Club Championship resulted in favour of Headquarters No. 2 Team, composed of :—D. W. Mill, D. R. Brown, James Thyne, James Paterson, and John Laurie, with a total number of 29 points, Airdrie Section being second, with a total of 49 points. D. W. Mill once more asserted his superiority as first in the race, which position gave him the Club Championship for the season—an honour justly deserved. As in former years we held a grand Inter-Club Run and Handicap, and Team Contest (open to all amateurs) from Maryhill Baths. It was held on November 25th, and proved a decided success. The entry comprised the leading cross country

runners in the West of Scotland, while no fewer than eleven clubs declared teams. After a brilliant finish, our Club Champion, D. W. Mill, showed his consistency by being first in the race, closely followed by J. J. M'Caffrey, Celtic Harriers, with Robt. Pettigrew, Coatbridge Harriers, third. The Handicap was won by Charles Scott, Elderslie Wallace Harriers, who was subsequently disqualified for his irregular entry form, pride of place being given W. Taylor, Paisley Harriers; W. A. Young, Coatbridge Harriers, second; and L. L. French, Motherwell Harriers, third. The Team Contest was a tie for first place between Elderslie Wallace Harriers and Hamilton Harriers, with a total of 23 points each, Bellahouston Harriers being third with 40 points. It is regrettable that a hitch has taken place two years in succession, but there can be no opinion the Club has always desired to treat all with the utmost fairness. It is to be hoped the event will be continued, as the interest is yearly increasing. The Junior Championship was held at Scotstoun, and resulted, as you all know, in favour of ourselves, with the smallest number of points the competition has ever been won with. Our successful six were:—Adam Bone, James Paterson, D. R. Brown, Joseph Brickley, J. C. Lindsay, Wm. Bell. Needless to say this triumph was particularly gratifying to your

humble servant. The Senior Championship was decided at Musselburgh, and on this occasion we had to be content with second place to Watsonians C.C.C. We were, however, well to the front—D. W. Mill being second, and James Thyne, perhaps the most improved runner in the Club, finishing fourth. The feature of the senior event was the large muster of our Members, nearly fifty making the journey.

The Annual Sports of the Club were held on June 16th. For once, the elements were in our favour, yet, notwithstanding the strictest economy, we had difficulty in making ends meet. The programme submitted was much as in previous years, the novelty of a boys' race and a tug-of-war contest having to be abandoned through lack of entrants.

The Club has been well kept to the front by our Members on the path, the successes of this season being very considerable. Hugh Barr once again received the broad jump championship, as also along with D. W. Mill figuring in the S.A.A.A. International Contest with Ireland.

The Club has been ably assisted in its work by the loyalty of its Sections. Airdrie has been wonderfully enthusiastic in all its doings, and has proved a decided

acquisition, while faithful Dumbarton has sent its quota with all its wonted regularity. There is no gainsaying the usefulness of Sections for fostering the sport. Such then is the brief summary of the Club's doings for the past year. To many of us it has not been without its anxieties, but I can assure you the one aim of the Committee and myself has been the prosperity of the Club. The Committee has been most attentive and regular throughout, while I have personally been ably assisted by my assistant, Mr. John Wilson. Your President has, notwithstanding his now being in double harness, been as regular as heretofore, and always been desirous of giving a willing hand. To one and all I tender my heartiest thanks for the support extended me, and my one hope is that the Club will go on and prosper, and that the name of Clydesdale Harriers will continue to be associated with all that is good and pure in the future as it has been in the past.
