

CLYDESDALE HARRIERS.

Rules.

- I.—That the Club be called the "CLYDESDALE HARRIERS."
- II.—That the object of the Club be the promotion of Amateur Athletics generally, and Cross-Country Running in particular.
- III.—That the general management of the Club be vested in a Committee not exceeding Eighteen Members, of whom Fifteen shall be elected at the Annual General Meeting of the Club, including, at least, a President, Vice-President, Secretary, Treasurer, Captain, and Vice-Captain. One representative to be elected by each Section. Five Members to form a quorum.
- IV.—That each Candidate for election, upon filling up a form (on which the Rules of the Club are printed) declaring that he is an amateur, according to the following definition:—"An amateur is one who has never competed for a money prize or monetary consideration, or for any declared wager or staked bet; who has never engaged in, assisted in, or taught any athletic exercise as a means of pecuniary gain; and who has never taken part in any competition with any one who is not an amateur";—and that he will abide by the Laws of the Club, shall be proposed by one Member and seconded by another, after which his name will be submitted to the Committee, and, if agreed upon, passed. Any Member of Committee shall have the power of demanding a Ballot in the case of any Candidate. One black ball in four to exclude.
- V.—That the Annual Subscription for Ordinary Members be Three Shillings and Sixpence, payable on the 1st of October in each year; and that the Subscription for Life Members be One Guinea. New Members' Subscriptions must be paid within One Month from the date of notice from the Secretary that their application has been passed, otherwise their election may be declared null and void.

VI.—That the Treasurer shall place before the Committee the names of all Members one month in Arrears for Subscriptions or other moneys, the Committee then having the power to enforce payment of such by legal proceedings, if necessary, and no one whose Subscription has been allowed to fall in arrears shall be entitled to any of the rights and privileges of Members of the Club.

VII.—That any Member intending to withdraw from the Club shall give written notice to the Secretary before the Annual General Meeting, or be liable for another year's Subscription.

VIII.—That any Member violating the Rules of the Club or of the amateur definition, as per Rule IV., or doing anything prejudicial to the interests of either, may be expelled from the Club by the votes of two-thirds of the full Committee.

IX.—That the uniform of the Club be Black Knickers and White Jersey, and that the Club Badge (a Horn and Whip, with the motto, "Excelsior,") be worn on the left breast at Athletic Sports, and the Gate Badge on back at Cross-Country Runs. (Members are specially requested to enter under the name of the Club at Athletic Meetings.)

X.—That the Committee shall allot the Management of the Headquarters Districts to certain of its members, who will look after said Districts, and assist the Secretary and Treasurer, so far as these are concerned, the Section Committees appointing their own District Managers, and otherwise looking after the immediate business of their Sections. The Committee shall appoint any Sub-Committees which they may consider advisable, and have full power to fill up vacancies in the General Committee and act for the Club (except to alter Rules), the majority in all cases to decide, the Chairman or President of the Club, however, having the power to appeal to a full Special General Committee Meeting. That the Meetings of Committees be held on the first Thursday of each month, or as near that date as possible, at least two days' notice to be given by the Secretary when, together with other current business, the Minutes of the Sub-Committees, as well as the Treasurer's Financial Statement up to the end of the previous month will be read and considered.

XI.—That the Annual General Meeting be held early in September, and called by Circular. The Reports of the Secretary and Treasurer shall be submitted, and the Office-bearers and Committee (with

Auditor to act in conjunction with one appointed by the Committee) appointed for the ensuing year. Twenty members shall form a quorum; a majority to decide. The Chairman shall have the power to appeal to a Special General Meeting on any special business, at which there must be Thirty Members present.

XII.—That a Special General Meeting may be called by the Committee, or by any Ten Members, or (in the above special case) by the Chairman on giving notice to the Secretary, who shall call the meeting in the same manner as the A.G.M.

XIII.—That these Rules be annexed to the Forms of Election and inserted in the Club's "Annual," and that no alteration in, or addition to, the Rules be made except at the Annual General Meeting, or at a Special Meeting called for that purpose. Notice of such alteration to be given to the Secretary, not later than 1st September, or ten days previous to any Special General Meeting.

Cross-Country Regulations.

I.—That Cross-Country Runs be held on Saturdays, from the 1st of October to the end of March, or on such dates as the Committee may fix.

II.—That the Club when out for a run shall be under the management of the Captain or Vice-Captain, or Senior Member of Committee present, who shall appoint a Pace-Maker and Whip for the control of each pack.

III.—That no one, when out for a run, shall be allowed to go ahead of the Pace-Maker, unless the run be a racing run, or the signal be given by the Pace-Maker for a race home.

IV.—That every member of the Club is expected to wear the Club Uniform at the Club Runs, and to support the management for the time being.

NOTES

FROM THE

Sixteenth Annual Report of the Club.

THE Membership of the Club now stands at 475, thirty-six new members having been admitted during the past year.

The Committee thought it advisable, for the good of the Club generally, to continue the policy they adopted a few years ago of declining the resignation of any Member until he stood fully clear on its books, so that though the figure shown above represents the Members who are liable to the Club, it also contains a number whose interest may be said to have lapsed. With reference to the financial position of the Club, it is pleasing to note a great improve-

ment, and the Officials look forward to a clearance of the debt during the following year, a consummation which can only be brought about by the hearty co-operation of all, and this is earnestly solicited. The season opened as usual with Headquarters and Sections joining together on October 6th, and continuing till the middle of March. Several visits were paid to the Sections, while Inter-Club runs were held with Paisley Harriers, Glenpark Harriers, Rosebank Athletic Club, Edinburgh Harriers, and Dennistoun Harriers. The attendances were fully up to previous season, but far from satisfactory, when the large Membership is taken into account. This indifference must be overcome, and special efforts made to induce the newly elected Members to turn out regularly to runs.

The Handicaps resulted as follows:—Five Mile Novice Handicap: 1st Man Home, A. G. M. Smart, Headquarters; 1st in Handicap, A. M'Donald, Airdrie Section. Five Mile Open Handicap: 1st Man Home, Adam Bone, Headquarters; 1st in Handicap, Archibald Bell, Airdrie Section. Club Championship and Team Contest:—

Club Champion, D. W. Mill, Headquarters: Team Contest, Captain's Team, 68 points, Vice-Captain's Team, 69 points, Airdrie Section Team, 74 points, Dumbartonshire Section Team, 89 points.

The Grand Seven Mile Open Handicap and Team Contest, held on 24th November, from Maryhill Baths, was again a huge success. The entry for the Handicap was one of the largest, while the Team Contest brought together no fewer than sixteen Teams, representing the flower of junior cross country talent. The Handicap resulted as follows:—1st in Race, J. J. M'Caffrey, Celtic Harriers, with Thomas Bennie, Whiteinch Harriers, second, and Richard Moffat, Larkhall Harriers, third. The Handicap was won by Samuel Bowers, who had an allowance of 7 min. 35 secs. The Teams finished in the following order:—1st, Larkhall Harriers; 2nd, Whiteinch Harriers; 3rd, Hamilton Harriers. The successful nature of this race was most pleasing to all concerned, and the Badges were presented to the winners during a social evening held after the race.

With reference to the Cross Country Championships, our performances could scarcely be improved upon. In the Junior Championship, run at Stenhousemuir on February 16th, our Team were only beaten by three points for first place, notwithstanding that we had won the event last year, and that three placed men were debarred from competing, and that we were deprived of the services of one of our selected Team and had to run a substitute.

In the Championship—the Blue Riband—run at Maryhill on 9th March, our ambition was gratified by securing first honours, an achievement giving more than ordinary gratification, as the critics averred we were never again to secure a Senior triumph, now that the heroes of former days had retired. D. W. Mill was first in the race, securing the individual honour, after a period of consistent running in the Championship of Scotland.

The Annual Sports were held in the Athletic Grounds of the Exhibition, the Club receiving a subsidy for conducting the Meeting. A most attractive programme

was submitted, and it is satisfactory to state that the confidence of the Executive was not misplaced, as both a good crowd and good sport were the outcome.

As hitherto, our Members were well among the Prizes during the Sports' Season. Special mention must be made of the honour conferred on two of our Members in being chosen in the International Athletic Team against Ireland at the Exhibition, viz.:—D. W. Mill and R. G. Murray. Too much praise cannot be given Mr. Mill for his magnificent race in the four miles. His victory could not fail to bring the Club's name to the front.

In the Exhibition Three Mile Team Race we were successful in the first tie, but in the final had to acknowledge defeat, while in the Squadron One Mile Race at the Rangers Sports we were also out of it, several of the selected team failing to turn up till too late.

As in former years the Sections have proved their worth, and it is gratifying that harmony prevails among all. Healthy rivalry is to be encouraged, and success can only result where it exists.

Much more could be said of the Club's doings, but space forbids. In closing, let me say your Committee have been most attentive in their attendances, while the chair has been almost to exception in the charge of your President. The financial side of the Club has been conducted with the utmost carefulness, where almost all have done their duty it is invidious to single out.
