CLYDESDALE HARRIERS.

Rules.

I.—That the Club be called the "CLYDESDALE HARRIERS."

II.—That the object of the Club be the promotion of Amateur Athletics generally, and Cross-Country Running in particular.

III.—That the general management of the Club be vested in a Committee not exceeding Twenty-four Members, of whom Twenty shall be elected at the Annual General Meeting of the Club, including, at least, a President, Vice-President, Two Joint Secretaries, Treasurer, Captain, and Vice-Captain. Five Members to form a quorum.

IV.—That each Candidate for election sends with his application the Subscription for the first year, which will be returned if he is not elected; and the Candidate must also make the declaration that he is an Amateur, according to the following definition:—"An amateur is one who has never competed for a money prize or monetary consideration, or for any declared wager or staked bet; who has never engaged in, assisted in, or taught any athletic exercises as a means of pecuniary gain; and who has never taken part in any competition with any one who is not an amateur":—and that he will abide by the Laws of the Club, shall be proposed by one Member and seconded by another, after which his name will be submitted to the Committee, and, if agreed upon, passed. Any Member of Committee shall have the power of demanding a Ballot in the case of any Candidate. One black ball in four to exclude.

V.—That the Annual Subscription for Ordinary Members be Three Shillings and Sixpence (for Honorary Members, Five Shillings), payable on the 1st of October in each year; and that the Subscription for Life Members be One Guinea.

VI.—That the Treasurer shall place before the Committee the names of all Members one month in Arrears for Subscriptions or other moneys, the Committee then having the power to enforce payment of such by legal proceedings, if necessary, and no one whose Subscription has been allowed to fall in arrears shall be entitled to any of the rights and privileges of Members of the Club.

VII.—That any Member intending to withdraw from the Club shall give written notice to the Secretary before the General Meeting in September, or be liable for another year's Subscription.

VIII.—That any Member violating the Rules of the Club or of the amateur definition, as per Rule IV., or doing anything prejudicial to the interests of either, may be expelled from the Club by the votes of two-thirds of the full Committee.

IX.—That the uniform of the Club be Black Knickers with white band at sides and foot, and White Jersey with Black Facings and the letter "C" in black on front and back. (Members are specially requested to enter under the name of the Club at Athletic Meetings.)

X.—For the purpose of administration the Committee may subdivide the Membership into Headquarters' Districts, and allot the management of those to certain of its members who shall be termed District Conveners, and who shall look after said Districts, and assist the Secretaries and Treasurer as far as these are concerned. The Committee shall appoint any Sub-Committees which they may consider advisable, and have full power to fill up vacancies in the General Committee and act for the Club (except to alter Rules), the majority in all cases to decide, the Chairman or President of the Club, however, having the power to appeal to a full Special General Committee Meeting. That the Meetings of Committees be held on the first Monday of each month, or as near that date as possible, at least two days' notice to be given by the Secretaries, or one or other of them, when, together with other current business, the Minutes of the Sub-Committees, as well as the Treasurer's Financial Statement up to the end of the previous month will be read and considered.

XI.—That two General Meetings be held in each year, one in the beginning of April and one in the beginning of September, and called by Circular. At the said Meetings the Interim Reports of the

Secretaries and Treasurer shall be submitted, while at the Meeting in September, in addition thereto, the Office-bearers and Committee (with Auditor to act in conjunction with one appointed by the Committee) shall be appointed for the ensuing year. Fifteen members shall form a quorum; a majority to decide. The Chairman shall have the power to appeal to a Special General Meeting on any special business, at which there must be Twenty Members present.

XII.—That a Special General Meeting may be called by the Committee, or by any Ten Members, or (in the above special case) by the Chairman, on giving notice to the Secretaries, or one or other of them, who shall call the Meeting by Circular.

XIII.—That these Rules be inserted in the Club's "Handbook," and that no alteration in, or addition to, the Rules be made except at the General Meeting in September, or at a Special Meeting called for that purpose. Notice of such alteration to be given to the Secretaries, or one or other of them, not later than 1st September, or ten days previous to any Special General Meeting.

Cross-Country Regulations.

I.—That Cross-Country Runs be held on Saturdays, from the 1st of October to the end of March, or on such dates as the Committee may fix.

II.—That the Club when out for a run shall be under the management of the Captain or Vice-Captain or Senior Member of Committee present, who shall appoint a Pace-Maker and Whip for the control of each pack.

III.—That no one, when out for a run, shall be allowed to go ahead of the Pace-Maker, unless the run be a racing run, or the signal be given by the Pace-Maker for a race home.

IV.—That every member of the Club is expected to wear the Club Uniform at the Club Runs, and to support the management for the time being.

NOTES FROM THE TWENTY-EIGHTH ANNUAL REPORT.

IN making a retrospect over the period which has elapsed since the last Annual General Meeting, we are enabled to compare our present position as a Club with that of a year ago, and to apply the lessons of another year's experience to the further management of our affairs.

We will begin by summarising the main features of the season's work.

The Cross-Country season proper was opened on 5th October with a Grand Meet at Clydebank Baths, and was brought to a close on 22nd March, with a run from the same centre. Inter-Club runs were held at intervals with the following Clubs:—Paisley, Boghead, Shettleston, Bothwell, Bellahouston, Paisley Juniors, Greenock Glenpark, Maryhill, Renfrew Y.M.C.A. and Olympic Harriers.

The Club Handicaps and Races resulted as follows:—

Five Miles Novice Handicap—1st, James Watt; 2nd, John J. Lawcock; 3rd, Robert Beresford. Handicap result—1st, Robert Beresford (3 min.); 2nd, John J. Lawcock (2 min.); 3rd, John C. Smith (3 min. 15 sec.). The entry for this race touched record, no fewer than fifty-eight taking part.

Five Miles Handicap—1st, Sam. S. Watt; 2nd, Duncan M'Phee; 3rd, James Watt. Handicap result—

1st, John J. Lawcock (2 min. 45 sec.); 2nd, James Watt (2 min. 30 sec.); 3rd, John Kirkland (5 min.).

Airdrie Marathon Race (Ten Miles)—1st, Robt. Bilsland (6 min. 30 sec.); 2nd, John Crawford (7 min. 30 sec.); 3rd, John Kirkland (6 min. 30 sec.). Fastest time (52 min. 40 sec.) was done by George Findlay.

Club Championship and Team Race—1st, Sam. S. Watt (Club Champion); 2nd, George Findlay; 3rd, J. C. Thomson. 1st Team—J. C. Thomson (3); W. Henderson (10); Alec. Peterkin (11); T. Barrie Erskine (14). 2nd Team—George Findlay (2); John J. Lawcock (5); John Kirkland (15); James Hutcheson (21). 1st men in losing Teams—Sam. S. Watt (1); Duncan M'Phee (4); Peter McGregor (6).

Seven Miles Confined Handicap (East)—1st, Wm. Henderson (3 min. 30 sec.); 2nd, John M. Learmonth (4 min. 30 sec.); 3rd, Robert Frew (2 min. 15 sec.). Fastest time was done by Sam. S. Watt (scr.).

Seven Miles Confined Handicap (West)—1st, J. J. Lawcock (2 min. 30 sec.); 2nd, John Kirkland (5 min. 45 sec.); 3rd, Stewart Thomson (4 min. 45 sec.). Fastest time was done by J. C. Thomson (45 sec.) who thereby became holder of the Dumbartonshire Challenge Cup.

Two Miles Flat Handicap (Celtic Park)—1st, Alex. I. Simpson (250 yds.); 2nd, Robert Bilsland (300 yds.); 3rd, Robert Frew (150 yds.).

Our Annual Team Contest and Handicap at Scotstoun in November, was as great an athletic success as ever, and although we invariably lose a small sum over this

event, yet that, we consider, is easily outweighed by the increased prestige which accrues to us as promoters.

The placings on the last occasion were—1st, Harry Hughes, W.S.H.; 2nd, A. McDonald, Monkland; 3rd, G. Cummings, Paisley. Handicap result—1st, J. A. Lang, Glenpark (5 min. 15 sec.); 2nd, A. C. Thomson, Hamilton (4 min.); 3rd, J. Strain, Shettleston (5 min.). The three leading Teams were—Garscube (16 pts.); Monkland (18 pts.); Greenock Glenpark (40 pts.).

Our positions in the Western District and National Championships this year were not so good as those of the previous year. In the former event our Team finished fourth, with D. M'Phee (3); Frank M'Cormack (18); James Watt (29); W. Henderson (36); J. J. Lawcock (43); and R. Bilsland (59); making a total of 188 points.

Our previous total was 88 points, a much better performance. In this year's race none of our men showed their best form, all seeming to be off-colour on the day of the race.

The same remark applies to the National Championship, in which we had to be content with third position. Our placed men were—Sam. S. Watt (3); J. C. Thomson (14); Robt. Frew (16); Alex. Loch (17); Geo. Findlay (18); and Alex. Mann (20).

We have still to win our first Western District Championship, but we feel confident that we have within the ranks now, the material with which to accomplish the feat. Our chances of success in forth-

coming Championships will depend on whether or not that material is properly worked up. An important part of the preparation for such races is the participation in Club races and handicaps throughout the season, as the teams to represent the Club are chosen chiefly on the results of these races. It is therefore essential that all our runners, and especially those of the younger school, should take part in them.

Our Annual Sports Meeting, held at Ibrox Park, on 31st May, was an unqualified success. From an athletic standpoint nothing better could be desired, while, thanks chiefly to the special attraction of the International Boxing Match, the Club came out well on the right side financially.

We held a second Meeting at Clydebank, on 21st June, which was athletically a great success. Unfortunately, owing to counter-attractions in the district on the same day, the attendance was not so good as had been expected, and the Club lost a few pounds on the venture.

Our members have been especially prominent on the track this year, and two of our members annexed Scottish Championships—the Walk and the Mile. The first event was won by Mr. Alex. Justice, after several years' attempts, so that his success this year was the result of long perseverance. Mr. Duncan M'Phee, however, who won the Mile, competed for the first time in a Championship event. The same may be said of Mr. Ralph Erskine, who finished second in the Half-Mile Championship. It is gratifying to know that three

other Scottish Champions, W. R. Sutherland, A. McLean and R. W. Patterson, have recently joined our ranks.

We have to place on record our appreciation of the kindness of Mr. Dugald Cameron, of Clydebank, who has presented us with a very handsome Shield for competition amongst our members.

The Second Annual Outing to Largs was held on New Year's Day, and was attended by a large party who enjoyed it immensely.

The attendance at the Club Runs throughout the season was very good, and several members qualified for perfect attendance medals. Nevertheless, there is yet room for improvement, and it is desirable that every active member should miss as few runs as possible during the winter.

As the Treasurer's Report will show, the finances of the Club have been somewhat augmented during the past season, which ought to be a matter of great satisfaction to us in these days of "slumped" athletics. We are still waiting patiently for the day when the public will support athletics as it now does football. Meanwhile we have the satisfaction to know that the Clydesdale Harriers are still holding their own in the firing line, and bearing aloft
