4 CONSTITUTION AND RULES.

I.—The Club shall be called the "WEST OF SCOTLAND HARRIERS."

II.—The Club shall be devoted to the promotion of Athletics and Cycling generally, and particularly to the prosecution of Cross-Country Running during the winter months, and its Membership shall be strictly confined to Amateurs.

III.—The Office-Bearers shall consist of an Honorary President, President, Vice-President, Two Joint-Secretaries, One Cross-Country Secretary, Treasurer, Captain, Vice-Captain, and Eleven Members, who shall form the Committee, by whom the affairs of the Club shall be managed. Seven to form a quorum. The Office-Bearers and Committee shall retire annually, but shall be eligible for re-election.

IV.—The Yearly General Meeting shall be held early in September in each year, at which the Joint-Secretaries and Treasurer shall submit their Annual Reports, and the Office-Bearers and Committee shall be elected by ballot, after nomination; a General Meeting shall also be held in April, at which the Cross-Country Secretary shall submit his report.

V.—The Joint-Secretaries shall be authorised to call a meeting of Committee at any time.

VI.—Special General Meetings may be called at any time, should the Committee deem them necessary, or on a requisition, signed by twenty-four Members, being presented to either of the two Joint-Secretaries, accompanied by a statement of business.

VII.—Two Auditors, not Members of Committee, shall be appointed at the Annual General Meeting to audit the Club Books and Accounts for the year.

VIII.—Applicants for Membership must receive the written recommendation of two Members, one of whom must be of the Committee, and shall be admitted provided a majority of the Committee present agree. All applications for membership must be accompanied by the amount of the Annual Subscription, such subscription to be refunded in event of the nomination not being entertained.

IX.—The Annual Subscription shall be as follows:—Members under 21 years of age at time of admission, or at 1st October in any subsequent year, shall pay 2/6, all others shall pay 5/. The Annual Subscription shall be due 1st October in each year, and any Member whose Subscription shall fall one month in arrear shall be liable to be struck off the Roll. Members over 21 and who have paid five or more consecutive Subscriptions of 5/—, on contributing not less than £1 1s. to the Funds of the Club, shall be entitled to Life Membership, provided a majority of the Committee present agree. Any Member (Life or Ordinary) intending to withdraw from the Club, shall give written notice to either of the Joint-Secretaries before the Yearly General Meeting, at which meeting the Roll shall be read, and all on the list held liable for their Subscriptions.

X.—No Member shall compete at any Sports which are not held under the laws of the S.A.A.A. or S.C.U. or other recognised governing body, and any Member infringing may be expelled from the Club.

XI.—Any Member violating the Rules, or guilty of any misconduct, may be expelled from the Club by the vote of two-thirds of the Committee. The expelled shall have a right of appeal to a General Meeting called at his request, not later than fourteen days from the date intimating the expulsion.

XII.—The Club Colours shall be black and pale blue.

XIII.—The Committee shall have full power to make, alter, or annul Bye-Laws.

XIV.—The Committee shall have full power to fill up any vacancy which may occur in the Committee or Offices of the Club during the year.

XV.—No alteration in, or addition to, the Rules shall be made excepting at the Yearly General Meeting, and unless supported by two-thirds of the Members present. Notice of proposed alterations must be made, in writing, to either of the Joint-Secretaries, on or before 15th August.

XVI.—The Joint-Secretaries shall have power to take legal action on behalf of the Club, for all monies due, and in connection with all matters contained in the foregoing Rules.

BYE-LAWS.

I.—That all Members shall obey the orders of the Captain, or his deputy, at Club runs.

II.—That at all runs the Packs shall be under the control of Pace Makers and Whips, who shall be appointed by the Captain or Vice-Captain; and no Member shall be allowed to go ahead of the Pace Makers unless it be a racing run, or the signal be given for a race home. The Pace Makers shall bring up the Packs when requested to do so by the Whips.

III.—No Member of the Club shall take part in any Club run except he be in the uniform of the Club, unless with the Captain's permission.

IV.—To qualify for any of the Handicaps, Members must have previously taken part in three Saturday runs; but Members resident outwith fifteen miles of Glasgow will be eligible by having previously taken part in *one* Saturday run.

V.—That the Committee shall have power to admit new Members at any Club fixtures, such admission to be subject to confirmation at the first following General Committee Meeting.

VI.—That at all Races and Handicaps promoted by the Club, a Starter, Timekeeper, Stewards, and Judges shall be appointed by the Committee to carry out the races.

VII.—That in Team Races, Squadron Races, Relay Races, Inter-Club Contests, or Club Matches, only members who have been one month or longer in the Club, and who have previously competed under the Club's name, will be eligible for selection to represent the Club.

VIII.—Medals will be given to Members racing under the Club's name, for the following performances (*to qualify for such, the time of such Member must be taken by official timekeeper*):—

I.—BRONZE MEDALLION.

No Member shall be entitled to more than one Medallion for any one event.

For Establishing Records at Race Meetings (no Member will be entitled to more than one Badge for one class of event in any one season).

3—GOLD BADGE.

For gaining National Championships (no Member will be entitled to more than one Badge in any one season).

Applications for Medals must be made to either of the Joint-Secretaries, in writing, within ten days from date of performance, giving full particulars, which must be properly authenticated.

4—GOLD BADGE

and Sir JOHN URE PRIMROSE CHALLENGE TROPHY.
For greatest number of Prizes, counting by points, in Events at Athletic Meetings in any one year.

OPEN HANDICAP EVENTS—

1st Prize, - to count 3 points.

2nd " - " 2 "

3rd, 4th, or Special Prize " 1 point.

INVITATION OR SCRATCH RACES—

1st Prize, - to count 2 points.

2nd " - " 1 point.

Points may be included for Prizes gained up to 30th September of each year, on or before which date claims for this prize must be made to either Joint Secretary.

The winner of this prize will hold the Sir John Ure Primrose Challenge Trophy for year.

NOTE.—To qualify for the foregoing, Members must enter FIRST under the name of the West of Scotland Harriers' Club, and thereafter may enter in conjunction with any Cycling, Football, or Athletic Club, but must not enter under the name of any other Harriers' Club. Members, when sending in entries, will kindly draw attention of the Secretary of the Meeting to see that they appear on the Programme as Members of the West of Scotland Harriers' Club.

At the Annual General Meeting, held on 9th September, it was decided that the Club take no part in Cross-Country running during the present crisis.

Training Quarters:—Maryhill Baths, Tuesdays and Thursdays. Trainers will be in attendance.

Entry Fee for each Handicap separately, 1/-; or for all four Handicaps together, 2/6. (Members desiring to enter for all four Handicaps must remit 2/6 prior to date of first Handicap.)

Note.—No Entry Fee required for Novice Race or Team Race.

Club Colours—Black and Pale Blue.

Club Championship.—The Pearce Cup will be presented to the Club Champion (first man home in 8 Miles Handicap), to be held for one year. The Club Champion will also be presented with a Gold Medal.

Warren Cup Competition.

1. That the Cup be called the "Warren Challenge Cup," and that it be held by the winner for one year.
2. That Members competing for the Cup must take part in six ordinary runs during the season, and must compete in at least three out of the four handicaps promoted by the Club.

3. That the Cup be won by the competitor who at the end of the season has scored the greatest number of points, the points to be awarded on handicap results, and placings to count as follows, viz.:

1st, ... 5 points. | 3rd, ... 3 points.
2nd, ... 4 " | 4th, ... 2 "
and all other competitors who finish to be credited with one point each.

4. In the event of two or more competitors having an equal number of points, the Committee will decide whether the tie be run off or the Cup held jointly.

5. If required, the winner must give satisfactory security for the safety of the Cup while in his possession, and for its return in good order and condition.

6. In the event of any dispute arising, the Committee to be the sole judges, and their award to be final.

7. The Winner of the Cup will be presented with a Gold Medal.

GENERAL.

SEASON 1913-1914.

THE ANNUAL GENERAL MEETING was held on the 9th September, 1914. Reports then submitted were most favourable, and unanimously approved.

The membership now stands at 212 Ordinary Members and 80 Life Members.

NATIONAL CROSS-COUNTRY CHAMPIONSHIP—Our team was defeated by Bellahouston Harriers. G. Mackenzie and D. Peat represented Scotland in Cross-Country International. H. Hughes was selected as reserve in this race.

Seven members attended all runs, viz: R. Craig, J. D. Jamieson, J. Landells, W. Shirlaw, W. Edmiston, J. C. A. Bogie and J. B. Wilson—the first mentioned four ran in all runs.

Mr. J. B. Wilson has added another year to his record, and has now sixteen years unbroken attendance to his credit. Mr. J. D. Jamieson has attended eleven consecutive seasons.

Our fifth annual theatre night, which was held in the Pavilion Music Hall, proved from all points of view satisfactory, and further justified the Club's enterprise in embarking upon this function.

Our Smoker in Alexandra Hotel was also a success, and was well attended by our own members and those of kindred clubs.

The Weekly Confined Meetings initiated at the beginning of Season 1912 have been productive of good sport, and a source of benefit to the competitors, but we lament the fact that they were poorly patronised, and the committee may require to reduce the number of these meetings in the future. Mr. Peter White again presented a prize for the most successful competitor at these meetings, and the aggregate prize—a handsome gold watch, was worthily won by Mr. J. S. Matthew with a grand total of 18 points, the runner-up being Mr. R. F. Gilbert with 17 points. To Mr. White we record our sincere thanks for this renewal of his kindness.

Our first Sports Meeting was again held in conjunction with Celtic Football Club, and although athletically a great success, it was very poorly supported by the public, the probable explanation being the many counter attractions in the City on that day. Our Second sports venture was held at Ayr on Glasgow Fair Saturday and in every respect was most successful.

Our Club has again been very successful in Relay Racing. Among Scottish Clubs at present we have no opposition. At Hawick, Greenock (Glenpark Harriers) and our own meeting we won easily over the 880, two 220 and 440 yards, and at Edinburgh Northern Harriers Meeting we were again successful in winning their Challenge Trophy over the four laps. We suffered our only defeat of the season at the hands of London Polytechnic Harriers—the world's champions over the former distance. Although allowed a handicap of ten seconds, we were just beaten, our English opponents putting up a new record for the distance.

In the Scottish Championships Duncan M'Phee again secured the mile and gained fresh laurels when he secured the half mile also. Tom Nicholson again won the Hammer Throwing and Weight Putting Championships, his chief opponent being Donald Rose of our own Club. Messrs. M'Phee and Nicholson were our representatives against England and Ireland in the Triangular Contest, when Mr. M'Phee won the Mile and Mr. Nicholson the Hammer Throwing and Weight Putting events. In the British Championships both M'Phee and Nicholson competed, the former running third in the Mile, a very creditable performance for a first attempt, his time being inside 4 mins. 23 secs., and the latter was second, being beaten by only seven inches, in the Hammer Throwing Competition.

To the Celtic Football Club we were indebted for favours during the past year, and for so generously granting us the use of Celtic Park for our Confined Meetings, and to Queen's Park Football Club for kindly granting us the use of their track for training purposes.

We also take this opportunity of thanking the gentlemen who so kindly presented prizes for Competition during the Cross-Country Season.

The Committee would urge upon the members that they give every assistance possible to carry on the working of the Club, and further strengthen it by introducing desirable gentlemen as members.
