**1. Chairman's Welcome and Opening Remarks**

1.1 Ron welcomed everyone to the meeting and extended a particular welcome to the new Chair of Scottish Athletics, Ian Beattie, and invited him to address the Commission members.

1.2 Ian summarised his background in road and cross country running, his key priorities and what he viewed as his role as Chair of Scottish Athletics. In particular he would like to see improved representation levels of Scottish athletes in the sport at UK level and on the participation side, those who don't necessarily see themselves as part of SAL, brought into the athletics fold. In his view, this needed better linkages with mass participation events and forging better connections with these athletes through clubs.

**4. Officials Training**

4.1 Alex advised that John Templeton (UKA) had contacted him regarding a Level 3 Endurance Officials Training Course which is taking place on 26<sup>th</sup> June. Alex suggested that the three officials who had completed the level 2 tutoring course – namely himself, Dave Cairns and Ann Stewart – should be nominated to attend. Agreed, with the addition of Ron Morrison.

**5. Gunstone Millennium Trophy**

5.1 Alex and Mark updated the Commission on progress with tracking down the missing trophy. The initial recipient in 2000 advised the trophy had been passed on via her parent but neither of the successive two winners recalled being presented with it. It was agreed to try and obtain a photograph of the trophy from Eleanor Gunstone and post a news item on the SAL website. The possibility of a replacement being required was noted.

**6. Entries, Programmes and Results**

6.1 The Commission noted the decision of Peter Jackson to retire from his role in providing a results service at championships over the past 17 years and expressed sincere thanks for the work he has done in this regard. Agreed a letter be sent from the Chair acknowledging Peter's substantial contribution to events over the years of his involvement.

6.2 As a result of Peter's retirement and building on the need to review an entries/results collaborative system for Road & Cross Country events, Ron advised that Nigel was exploring options subject to suitable funding being identified. Ron is preparing a specification for a system which would be circulated to Commission members for comment once complete. A number of existing systems in operation were discussed and the urgency of the matter noted as it required to be in place for the start of the 2012/13 Winter Season in October. Progressing this item would also incorporate actions RRCC2010-21: NH – Non-SAL athletes in Championships and RRCC2011-45: AJ/RM – GGH on entry procedures for Championships.

7.1 To progress representation from the West District, it was agreed all West clubs would be emailed on this with the offer of a nominated individual, who, if no objections were received by a given date, would be approved and invited to the next meeting.

**8. European Team Competition**

8.1 Ron outlined a proposal that would result in the National Cross Country Relays being the selection race for the European Team Trial race on basis of only eligible athletes under UKA rules being fielded. This would bring SAL in line with selection processes for English Athletics. Agreed this would be implemented from the start of the 2012/13 Winter Season. Letters to be sent to Edinburgh AC and Central AC advising of the change in selection procedures and thereafter the policy would be publicised widely to all clubs.

**9. Championship Entry Fees**

9.1 Discussion on this item incorporated Action: RRCC2011-45. Alex spoke to the paper circulated previously and the Commission discussed the merits of a 50 pence increase on Cross Country Championship entry fees. This was agreed along with an increase to £200 of the host fee to clubs. It was also agreed to have an annual review of both fees and host fees as a standing agenda item for the Commission.

**10. Inter District Championships**

10.1 Following discussion at the previous meeting, Nigel reported on a recent meeting held with NOVA on a range of matters relating to their programme of events in Scotland and the opportunity for improved linkages with Scottish Athletics. Strong representation was made as part of this meeting on the revised format for the Great Edinburgh Cross Country not being suitable for continued inclusion of the Inter District Championships and the view was that positive discussions had ensued. Written follow-up to the meeting from NOVA was awaited which would indicate if SAL's points had been taken on board.

10.2 As part of the discussion on this event, race distances had been reviewed and it emerged that the distances athletes race over the cross country season were not aligned appropriately. As a result of discussions, the Commission agreed to expand the paper previously circulated to include Inter Counties and international competition distances. The Commission also agreed to a revised programme for cross country championships to apply from the 2012/13 Winter season which would have under 17 and under 20 women running together rather than the current arrangement of under 15/under 17 and under 20/senior women's races. It was noted this would mean an earlier start to the programme to incorporate the additional race required. **Action: RRCC2012-24: AJ/RM/MD/GS/SD**

11.1 Ron spoke to the paper which had been previously circulated and as it was subsequently agreed for implementation, advised this would now be posted on the SAL website.
